Fostering Futures program

Fostering Futures is a voluntary program that includes housing support, education and vocation assistance, and other independent living needs.

Are you eligible?

You may be eligible if you turned 18 while in foster care and are currently under 21.

How to apply:

- Ages 18–21 should through your former foster care worker or other local Department of Social Services (DSS) representative.
- If you're under 18, or if you left foster care after you turned 18 and you're currently under age 21, talk to your foster care social worker about your interest in applying.

Ages 18–26

Former Foster Care program

The Former Foster Care program provides necessary support and services for former foster care youth.

Are you eligible?

You may qualify for Medicaid benefits through the Former Foster Care program if you were in foster care on your 18th birthday.

How to apply:

The benefits and services are designed to make a difference in your life.



Care coordination

The Foster Care Specialty Plan has a dedicated team of care managers who can:

- Provide guidance as you transition into adulthood.
- Help you find doctors, dentists, therapists, etc.
- Remind you when it is time to get a physical or go to the dentist.
- Help you find community resources, like housing and job support.

Foster Care Specialty Plan has qualified dedicated staff and programs to help with the following needs:

- Legal support if you have past or current charges and need support our judicial liaison can help you navigate the system
- Legal and judicial support
- Housing supports
- Employment and educational support
- Family support
- Maternal support

Benefits beyond what you expect

At the Foster Care Specialty plan, we offer important extras just for being a member. To request these services, please call Member Services or ask your care manager for more information.



Employment support

Eligible members can select one of the following options to help support their employment pursuits:

- Industry certification assistance: \$100 gift card to help cover the costs of certifications.
- Uniform support: \$100 gift card to purchase employment-required uniforms or work attire.
- Styling support: \$100 gift card to use toward supplies or grooming products.
- Tools purchase assistance: \$100 gift card to purchase tools.



GED assistance

Members ages 18 years and up can receive up to four vouchers for the for the General Education Development (GED®) test. The GED® test covers four subjects including math. science, social studies, and reasoning through language arts.



WW (Formerly Weight Watchers)

Members can receive a WW voucher to help cover initiation fees and 13 weeks of membership. To request, please call Member Services.



Transportation essentials

Members who are pregnant or members enrolled in the Job Connections program can select one of the following:

- \$100 gift card to purchase public transportation pass
- \$100 ride share card
- \$100 gas card



Community transportation

All members are covered for two round trips or four one-way trips per month to the grocery store, food bank, job interviews, places of worship, government offices (DSS, DMV, post office, and Social Security office), and even support groups.

- 24 round trips or 48 one-way trips annually.
- Non-medical trips have limited restrictions to milage and timeframes.
- 30 miles roundtrip in the urban setting and 60 miles roundtrip in a rural area.
- Trips can be requested Monday through Friday between 8 a.m. to 5 p.m..

Get Connected to Better Health

The Get Connected to Better Health program provides a smartphone with unlimited talk, text, and data. It's preloaded with a selection of digital and virtual health tools to select eligible members Enrolled in the Case Management program.



Identification assistance

Eligible members 15 years or older can receive a \$35 gift card to help cover the cost of obtaining a driver's license, birth certificate, social security card, or state identification card once per lifetime.



Post-secondary education support

Members ages 16-21 pursuing postsecondary education within the next year can select one of the following options¹:

- \$50 gift card to purchase Scholastic Assessment Test (SAT) or American College Test (ACT) study guides.
- \$100 gift card to use toward college application fees.
- \$100 gift card to use toward textbooks and dorm room items.



Chromebook

Eligible Foster Care and Adoption Assistance members ages 17 and up can receive a Chromebook² after completing a Health Risk Assessment(HRA).



Over-the-counter and personal care items

Foster Care and Adoption Assistance members ages 8 and up who complete a wellness visit can receive up to four \$25 gift cards to purchase personal care and hygiene products in stores or online. Products for selection may include items³, such as:

- Over-the-counter pain relievers, cough/ cold medicine, digestive aids (laxatives and antacids), vitamins/supplements, etc.
- Personal care items such as toothbrushes, toothpaste, soap and body wash, shampoo/conditioner, hair combs/brushes. etc.
