Value-based care is transforming the way health care is delivered – allowing practices like Tidewater Physicians Multispecialty Group (TPMG) to deliver whole-person, high-quality care to their patients while lowering costs.

Since becoming an Enhanced Personal Health Care (EPHC) participant in 2013, TPMG has made dramatic strides in the health care experience they provide their patients. The key to their success is a consistent focus on **proactive care coordination**. The results speak for themselves:









Reduced ER visits by 23%

- Created ER alternatives including after-hours office and on-call doctors for extended after-hours needs
- Call patients and hand out flyers on appropriate use of the ER vs. urgent care
 or the office
- Coordinate with area hospitals so TPMG gets daily ER visit reports to follow up on
- ✓ Reach out to patients after ER visits to help reduce future ER visits

Cut avoidable hospital readmission rates by 30%

- Coordinate with area hospitals so TPMG is notified when their patients are admitted
- ✓ TPMG care coordinator visits patients before they're discharged and calls after discharge to make sure they understand and follow their discharge care plan
- Created a transition-of-care model focused on medication adherence, infection prevention and scheduling follow-up care for discharged patients

Increased generic drug dispense rates by 3.8%

- Use EPHC data to track dispense rates
- ✓ Work with prescribers to educate them on generic and lower-cost drug alternatives
- Added pop-ups in electronic medical record system that alert providers when there's a generic alternative
- Created a scorecard to hold providers accountable for prescribing generics

Reduced site-of-service costs for radiology tests by 4.5%

- Use Anthem cost-of-care tools to help identify lower-cost facilities for radiology tests
- Provide preferred lab site list for each TPMG office

Results that improve health and lower costs

With the robust patient data, financial incentives and other resources that EPHC provides, TPMG has transformed the way they deliver care. By focusing staff and resources on proactive care coordination, TPMG is improving their patients' health and lowering costs.
