Professional provider network participation

If you wish to become a contracted provider or add a professional provider to your existing group, please complete an Anthem digital provider enrollment application, available at [Availity.com](https://www.availity.com). Go to **Payer Spaces for Anthem** and select **Provider Enrollment**.

Ancillary provider and facility network participation

Ancillary and allied health providers include but are not limited to acupuncture, ambulance, audiology, cardiac event monitoring, dialysis, durable medical equipment (DME), hearing aid supplier, home health, home infusion, hospice, immunization clinics, physical/occupational/speech therapy, registered dietician, orthotics, prosthetics, supplies, radiology/imaging, and reference laboratories. Facilities include acute care, rehabilitation, long-term acute care (LTAC), and behavioral health facilities, and surgery centers.

Before you begin

If your organization is not currently registered with Availity, the person designated as the administrator should go to [Availity.com](https://www.availity.com) and select **Register**. Availity administrator(s) will automatically be granted access to Anthem's digital provider enrollment in **Payer Spaces**.

For organizations already using Availity, your administrator(s) will automatically be granted access to Anthem's digital provider enrollment in **Payer Spaces**.

If you are not an administrator and already using Availity, go to **My Account Dashboard > My Account > Organization(s) > Administrator Information** to find one. Your administrator will need to add Provider Enrollment to your user role in order to access Anthem's digital provider enrollment in **Payer Spaces**.

How credentialed providers apply online

Log on to [Availity.com](https://www.availity.com) and select **Payer Spaces > Anthem Blue Cross and Blue Shield > Applications > Provider Enrollment** to begin.

Anthem's digital provider enrollment uses the Council for Affordable Quality Healthcare (CAQH) ProView application. CAQH is available at no cost and eliminates duplicative data entry needed to request Anthem network participation. Please ensure all sections of the CAQH Proview profile are complete and accurate. You must authorize Anthem so we can access your self-reported and attested information.

How non-credentialed providers apply online

Log on to [Availity.com](https://www.availity.com) and select **Payer Spaces > Anthem Blue Cross and Blue Shield > Applications > Provider Enrollment** to begin. Fill in the required Anthem digital provider enrollment information and submit the application.

After you apply

All the information provided in Anthem's digital provider enrollment application will be used to determine contract eligibility. You will receive an application ID upon successful submission. The online application will guide you throughout the enrollment process, providing status updates using a dashboard. As a result, you know where each provider is in the process without having to call or email for a status.
